

# SafetyBarrierManager

## REGISTERED LIMITED END-USER SOFTWARE LICENSE (RLEUSL)

The legal and contractual relation between You (a legal entity or an individual person, hereinafter referred to as the *Licensee*) as a user of the registered version of the SafetyBarrierManager program and associated software (hereinafter referred to as *Licensed Software*) and Nicestsolution, Jyllinge, Denmark (hereinafter referred to as *Licensor*) is governed by three complementary agreements:

1. The End-User License Agreement for SafetyBarrierManager (unregistered use) – this agreement shall be accepted by all users of the SafetyBarrierManager software prior to installation of the software on the users' computers, both for the registered and unregistered users. This agreement deals with copyright, warranty and liability and legal disputes and is attached to this agreement as "Appendix 1";
2. The confirmation of order, invoice or other agreement between the Licensee and Licensor that settles the *License Fee* to be paid by the Licensee, *the License Period*, the maximum *Number of Users* that are allowed to use the Licensed Software and the maximum *Number of Hours of Support* that the Licensee is entitled to receive from the Licensor or its Intermediate Agent;
3. The conditions as stated herein that deal with the provisions of handling the *License Number* that is used to register and access the Licensed Software.

IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE AGREEMENT THEN DO NOT PAY THE LICENSE FEE OR REJECT THE AGREEMENT IF THE LICENSE IS GRANTED FOR FREE, AND DO NOT ACTIVATE THE LICENSE NUMBER.

### 1 Grant

In consideration of the payment of the License Fee and the acceptance of the provisions of this License, the Licensor grants the Licensee a non-exclusive and non-transferable license, for internal use only, for the maximum Number of Users to run the Licensed Software as a registered user by using a confidential registration license number ("License Number") during the License Period and subject to and in accordance with the following provisions.

The conditions of the END USER LICENSE AGREEMENT FOR SAFETYBARRIERMANAGER (EULA), attached as Appendix 1, apply in addition to the conditions in this agreement. In case of contradiction between the conditions in Annex 1 and this RLEUSL, the conditions of this RLEUSL apply.

The Licensee shall supervise the use of the Licensed Software and the License Number, control access to it and keep it secure. The Licensee remains fully responsible at all times for all acts and omissions of anyone it allows to use the Licensed Software and the License Number and for ensuring such person understands and observes this RLEUSL. The responsibility includes without limitation any employee, student, independent contractor or visiting researcher.

The Licensee acknowledges that the License Number is confidential. Unless required to disclose by law, stock exchanges or in connection with legal proceedings the Licensee shall keep the License Number confidential and secret, together with all information supplied by the Licensor in relation to the Licensed Software or License Number, which is otherwise identified as confidential. The obligations in this Clause do not apply to information that is in or becomes part of public domain in a lawful manner. The obligations in this Clause

shall survive the expiry or earlier termination for whatever reason of the Licensed Period for a period of 3 (three) years.

Except for the rights expressly set out in this License, no license is granted and all rights, title, interest in and to the Software (including without limitation any patent rights) in all formats and media throughout the world now or hereafter are and shall remain the exclusive property of the Licensor and other rights holders.

## 2 License Period

Unless otherwise agreed between Licensee and Licensor on the License Fee, two schemes are used for the License Period:

- Yearly subscription: The License Period begins as of the day of first payment of the License Fee and renews automatically for another year until it is terminated with 3 months written notice from the Licensee to the Licensor. The Licensee shall pay the License Fee each year until termination of the License Period. The Licensee is entitled to download and use all updates and versions of the Licensed Software that are issued during the License Period. The access to the Licensed Software terminates after termination of the License Period.
- Perpetual License: The License Period begins as of the day of payment of the License Fee. The License Period and access to the Licensed Software does not end otherwise then according to clause 5 below or force majeure. The Licensee is entitled to download and use all updates and versions of the Licensed Software that are issued during the first 6 months of the License Period and all updates of the licensed version of the Licensed Software as long as such updates are issued by the Licensor.

## 3 Licensed Software

The Software is "SafetyBarrierManager". The software can be downloaded from internet site:

## 4 Support

The Licensee is granted a maximum of Number of Hours of Support with respect to installation and running of the Software. Requests for support are made via the contact form available on <http://safetybarriermanager.com> if you paid the License Fee directly to Nicestsolution. If you paid the License Fee to an Intermediate Agent, requests shall be directed to that Intermediate Agent. Support is delivered by e-mail or telephone.

## 5 Termination

The Licensor may terminate the License Period early by written notice if the Licensee fails to comply with any provision of this License, including the provisions of the End-User License Agreement for SafetyBarrierManager (unregistered use) as included as Appendix 1 herein. Non-compliance with the License includes without limitation non-payment of the whole or any part of the License Fee, within 14 days of being required to do so in writing.

Upon Termination the Licensee shall immediately stop using the Software in combination with the License Number and shall certify to the Licensor within 5 (five) days that the Licensee has uninstalled the Software from its systems. The expiry or termination of the Licence Period is without prejudice to any other rights or

remedies of either party under the License or at law and does not affect any rights or obligations which have arisen or accrued up to and including the date of expiry or termination.

## **6 General**

The Licensee shall not assign or otherwise transfer all or any part of this License or the License Number to any third party, without the Licensor's prior written consent.

This License together with the attached EULA (Appendix 1) and the agreement settling the License Fee; the Number of Users, the License Period and the Number of Hours of Support, constitutes the entire agreement and understanding of the Licensor and Licensee in relation to the subject matter of this License. This License cannot be waived or varied except in writing signed by the Licensor. If the whole or any part of a provision of this License is void, unenforceable or illegal in a jurisdiction, it is severed for that jurisdiction, unless it alters the basic nature of this License or is contrary to public policy.

## **7 Privacy**

The Licensee agrees that Licensor registers and files information necessary to maintain the terms of the License. This information consists of user names connected to encrypted identification of hardware, and time of the latest manual or automatic registration update via Licensed Software. Unless required to disclose by law, stock exchanges or in connection with legal proceedings the Licensor shall not disclose this information to any third party. Licensor may only use the information to provide support to the Licensee with respect to operation of the Licensed Software.

## **8 Force majeure**

Licensor is not liable for breaches in the rights obtained by this license, including access to the Licensed Software, due to force majeure, including, but not limited to: loss of internet connectivity, bankruptcy, or death or invalidity of key employees of Licensor.

## Appendix 1

### End-User License Agreement for SafetyBarrierManager (registered and unregistered version)

This License Agreement is made by and between Nicestsolution, Jyllinge, Denmark (hereinafter referred to as Licensor) and you as user (hereinafter called the Licensee). By installing the SafetyBarrierManager program and associated software (hereinafter referred to as Licensed Software), the Licensee is agreeing to become bound by the terms of this License Agreement. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE AGREEMENT, DO NOT INSTALL OR USE THE LICENSED SOFTWARE.

#### Copyright

The copyright of the Licensed Software and its associated documentation is owned by the Licensor. These rights cover every part and further developments of the program, associated software and written documentation.

#### Unregistered License

Licensor hereby grants to Licensee a non-transferable and non-exclusive single-user license to use the Licensed Software on any one computer that is under the Licensee's control and to make copies for back-up purposes only in support of the permitted use. All copies must reproduce and include the Licensor's copyright notice. It is the Licensee's responsibility to ensure that anyone who has authorized access to the Licensed Software complies with the provisions of this Agreement.

#### Registered License

If Licensee and Licensor have agreed on a Registered Limited End User Software License, then the additional terms of that Registered Limited End User Software License apply as well.

#### Copyright acknowledgement

The Licensee shall acknowledge the authors and use of the Software in the publication of any results achieved through use of the Software. The Licensee shall reproduce a copyright notice on every copy of the Software (including partial copies) and on any accompanying manuals and documentation in the form "Copyright © [ ] Nicestsolution. All rights reserved", with the date the Software was written inserted after the sign "©".

#### Restrictions.

It is forbidden to reverse-engineer, de-compile, disassemble, or make any changes to the Licensed Software. It is forbidden to create derivative works based on the Licensed Software. It is forbidden to unlock the limitations of the unregistered software, unless the Licensee and Licensor have agreed on the additional terms of a Registered Limited End User Software License.

#### Distribution

The Licensed Software is distributed by Nicestsolution, Jyllinge, Denmark. The unregistered License is granted for free. No information on the Licensees using this unregistered software is registered or filed.

## Limited warranty

The Licensee acknowledges that the Software is under development and may contain errors, that it is provided "as is" and that specific results and uninterrupted operation cannot be guaranteed. The Licensee therefore agrees that the existence of errors in the Software shall not constitute a breach of the License. The Licensor shall not have any obligation to upgrade, "bug-fix", provide documentation, support or maintenance services or provide any information, assistance or consultancy in relation to the Software.

No warranty, condition, undertaking or term, express or implied, statutory or otherwise, is given or assumed by the Licensor, including without limitation as to non-infringement or the condition, performance, satisfactory quality or fitness for purpose of the Software and all such warranties, conditions, undertakings and terms are hereby excluded to the fullest extent permitted by law.

## Limited liability

The Licensee shall indemnify the Licensor and its officers, directors, Council members, employees and representatives (Together "Indemnitees") against all third party Claims that may be asserted against or suffered by any of the Indemnitees and which relate to the use by the Licensee of any of the Software. "Claims" means all demands, claims and liability (whether criminal, civil, in contract, in tort, or otherwise) for losses, damages, legal costs and other expenses of any nature whatsoever and all costs and expenses (including without limitation legal costs) incurred in connection therewith.

To the extent that any Indemnitees has any liability in contract, tort, or otherwise under or in connection with this License, including any liability for breach of warranty, their liability shall be limited in accordance with the following provisions of this Clause.

The aggregate liability of the Indemnitees shall be limited to the total amount of any License Fee paid for the Licensed Software during the last five (5) years prior to the date of the liability claim.

In no circumstances shall any of the Indemnitees be liable for any loss, damage, costs or expenses of any nature whatsoever incurred or suffered by the Licensee that is a) of an indirect, special or consequential nature or b) any loss of profits, revenue, business opportunity or goodwill.

Nothing in this License excludes any person's liability to the extent that it may not be so excluded under applicable law, including any such liability for death or personal injury caused by that person's negligence, or liability for fraud.

## Applicable law

This License Agreement shall be governed by Danish law.

## Disputes

Any dispute arising out of or in connection with this License Agreement shall be settled by the Maritime and Commercial Court of Copenhagen.
